The Altoona Area Kennel Association, Inc. offers dog training classes at a fair market fee. The club occasionally offers seminars, specialty classes, run thrus and public demonstrations. Classes are organized and taught by volunteer members. The demonstrations, seminars, and run thrus are planned and presented by a host member.

Disruptive and aggressive dogs, (aggression shown towards dogs or people), are not permitted to participate in the club classes, seminars, run thrus, or demonstrations. These club activities are to provide instruction and education in a safe environment that is conducive to learning. If a dog is disruptive or aggressive, it is the instructors/hosts right to **ask the handler to withdraw the dog from the activity**. The above mentioned are the usual functions of the club; however, aggressive and disruptive dogs are not permitted to participate in any club event.

In the event that a dog is withdrawn from a paid activity due to disruptive or aggressive behavior, the unused portion of a fee will be returned to the handler if pertinent; however, the used portion of the class fee will be nonrefundable. The AAKA, Inc. is objective and supportive of handlers with dogs that exhibit undesirable behaviors and encourage the handlers to seek a professional evaluation of the dog.

I understand that attendance to a dog training class is not without risk to me, my dog, or any guest who may attend. I realize some of the dogs attending class may be difficult to control, possibly causing injury even when handled with the utmost care.

I agree to waive and release the AAKA, Inc., its officers and members from any and all liability of any type, for injury resulting from the action of any dog, and I assume the risk of such damage or injury while attending any training session or other functions of the AAKA, Inc.

I further agree to indemnify and hold harmless the AAKA, Inc., its officers and members from all claims by any member of any family or any other person accompanying me to any training session or function of the AAKA, Inc. as a result of any action by any dog, including my own.

Payment for classes will not be refunded for any other reason, except for injured/incapacitated dogs for the remaining unused classes. The handler must notify the instructor of withdrawal from class and present a veterinarian's letter on official veterinary letterhead prior to the start of the next scheduled class.
